Exploring resilience

April 2021 began with hope, energy and anticipation as the team met in-person in April 2021 for 3 days of bonding, brainstorming and strategising towards the vision we are continuing to build towards. The team went back rejuvenated, stronger and ready to work with our partners and their communities. No one was ready for what was to come. The next few months brought the second wave of the pandemic and left individuals, families, organisations and communities dealing with loss and grief. As a team and as an organisation, we rallied around each other, our partners and our supporters. We began to explore how resilience showed up in communities around us.

The two elements that constantly got reinforced through the year even as it helped us in being resilient was the importance of having a safe space to explore, express, connect and have fun and knowing that you are part of a larger collective or community of people. We tried to create this for ourselves as a team and for our partners. This conviction strengthened through the year and resulted in our first Leher Confluence and the envisioning of our first Safe Spaces Project with one of our Leher partners. As we complete three years and take stronger and larger steps towards our vision, we know that it is only as a collective that we can all be stronger and resilient individuals.

3 years of Mudita Foundation

In the last three years since our inception, we have grown in the team we have, the programmes we conduct, the partners we consciously collaborate with and the outreach and impact we have achieved. What stands out for us is the growing collective we are able to build towards our vision. Every partner, every supporter, every participant, every

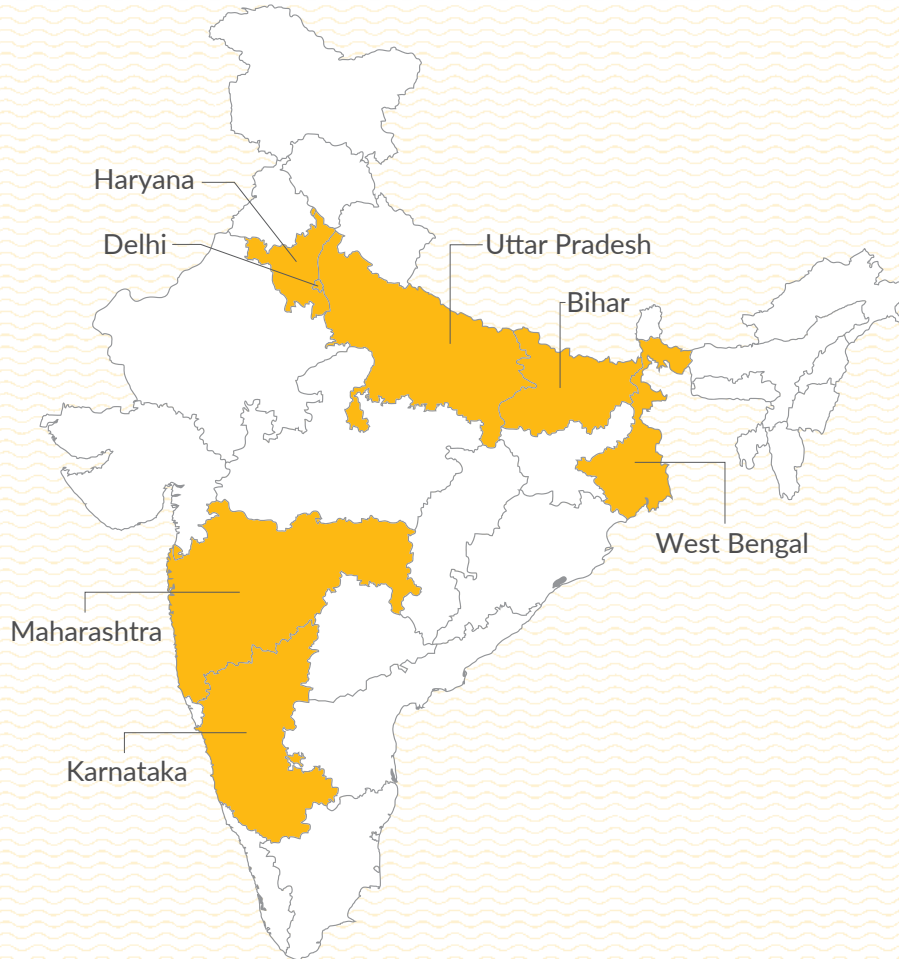

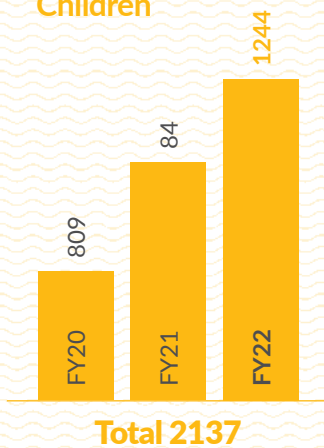

Mission

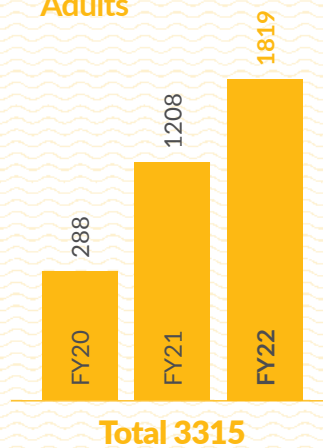

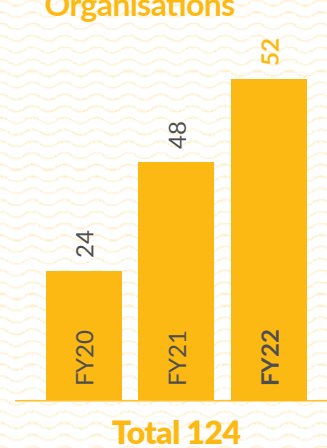

The silence around child sexual abuse, the denial of human trafficking in our midst and the ignorance around online abuse make it necessary to initiate conversations with everyone before getting into capacity-building and training. It is also important that these conversations happen with everyone, everywhere, in every walk of life.

We firmly believe that each and every individual in the society holds the responsibility towards creating a safe environment. Most of us lack the realization towards this responsibility as there is no awareness and often these issues are brushed under the carpet with the notion of 'not our business'. We believe that safety is not a private but a public issue but to achieve that realization collectively it is imperative to start having uncomfortable conversations about the prevalence of abuse, violence and exploitation around us, about our ignorance and denial towards it, and most importantly about our role as individuals and society towards tackling it.

Last year, we were able to take such conversations to 2845 participants in 52 different groups that included children, adolescents, educators, youth groups, college students and community women in partnership with institutions and organisations working with children, youth and women.

While some sessions focused on an overview of the issue for awareness, some were specific and focused on safe and unsafe behaviour (in the context of children and adolescents), POSH -the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, ensuring online safety, developing child protection policies, building safe classrooms and understanding the concept of the slavery footprint.



With Delhi Public School International, Gurugram, we conducted awareness sessions on POCSO for all the teachers in the schools along with a focused training with a smaller group on the tools to create safe classrooms. With the Navy Children

School in Visakhapatnam, it was an intensive engagement with the teachers as well as students starting from grade 6th till 12th. It brought to light the real risks faced by the students, especially in the virtual space, again reiterating the need for such conversations.

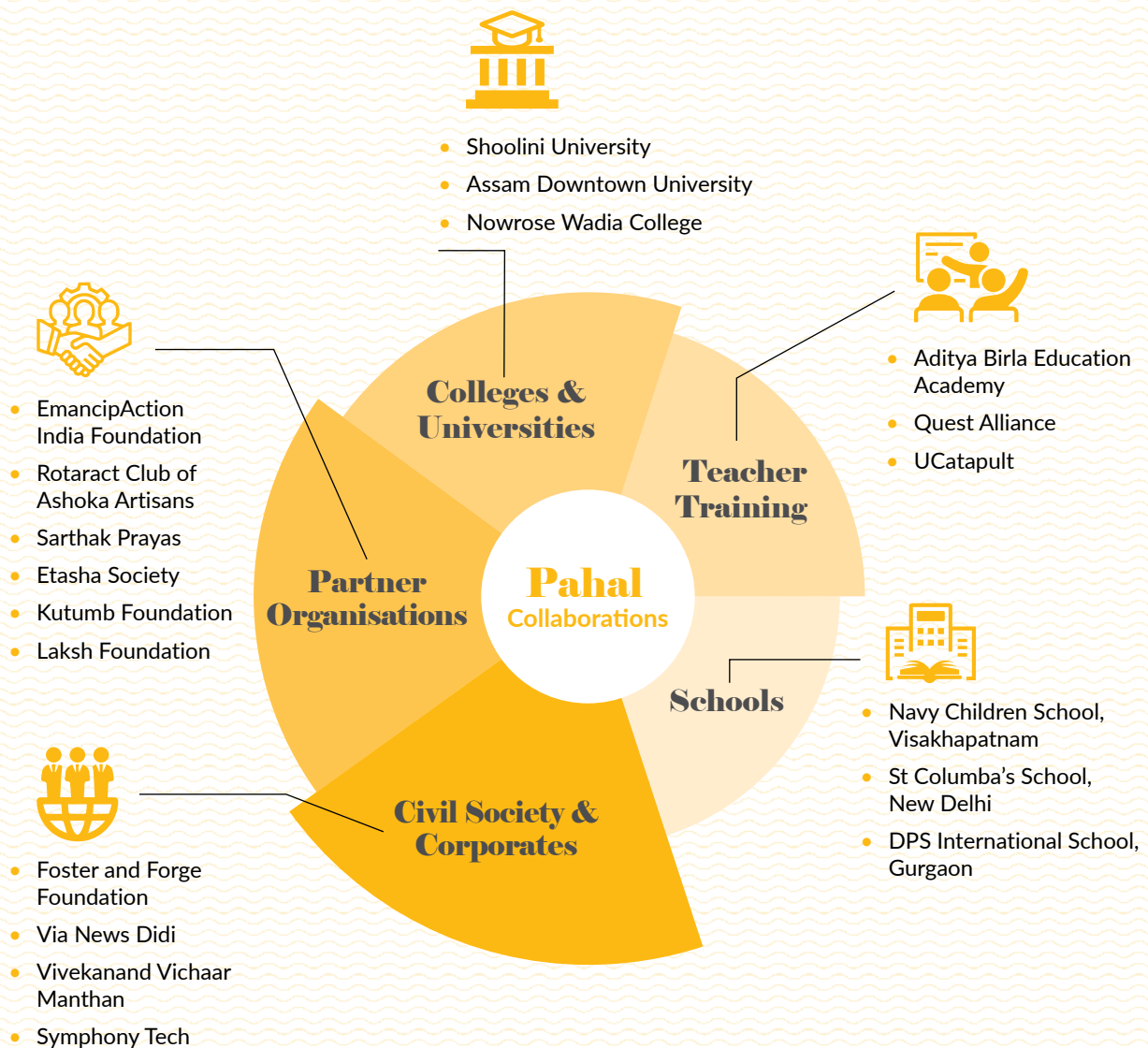

At Shoolini University, the Pahal sessions with the management students were not limited to just awareness conversations, but engaged students in developing creative solution-based action plans. Likewise, the enthusiastic team of Via News Didi went ahead to talk about the issue of human trafficking and slavery footprint after their session with us, through a podcast and newsletter for their audience.

Leher

“Safety and security don’t just happen - they are the result of collective consensus and public investment. We owe our children, the most vulnerable citizens in our society, a life free of violence and fear.” –Nelson Mandela

It is critically to respond to issues of safety and protection of children and women in a holistic manner that takes into consideration aspects of their lives such as education, health, livelihood security, and personal agency. This can only be achieved with awareness and capacity building that leads to the ability to identify and respond to situations of abuse, violence and exploitation while working towards prevention of abuse and violence in our spaces and communities.

At Mudita Foundation, we partner with community-based organisations, schools and universities to educate and build

their capacity to recognise risks, record and respond to instances of child abuse, online sexual abuse and exploitation and other forms of gender based violence and exploitation within their communities.

Leher is a structured program that uses appropriate and context specific tools for capacity building for education, empowerment and action, to facilitate creating safer environments, protecting survivors of violence and making safeguarding a mandate within all NGOs, schools and other civil society organizations. This program is conducted in three phases:



Phase 1

- Build capacity and empower organisation teams and community groups with perspective and skills to become advocates of safety and protection through contextual and appropriate interventions in communities.

- Establish 'safe spaces' for children, adolescents and youth in communities with zero tolerance for abuse, violence, and exploitation

In 2021- 2022 we continued our engagement with last year's Leher partners namely, Vidya India, Kutumb Foundation and Ritinjali Foundation and partnered with 5 new organizations across the country working with children and women namely:

- Calcutta Kids
- Laksh Foundation
- Etasha Society
- Vihaan

Phase 2

- Initiate organisation Child Safeguarding and Protection Policy as a commitment to action in communities; Facilitate baseline perception studies for evidence based information and data from communities

Phase 3

- Initiate community action with partner organisation on issues of abuse, violence and exploitation based on the values of social justice (specifically child sexual abuse, human trafficking, and online abuse)

Each of these organisations has a different approach and focus of working with vulnerable groups. While Kutumb, Ritinjali, Laksh and Vidya focus on holistic educational support for children, Etasha focuses on employability of youth. Calcutta Kids works on issues of health. Foster and Forge works with government school teachers in Uttar Pradesh through a model of capacity-building and mentoring. Vihaan is an anti-human trafficking organisation working with vulnerable communities, Child Care Institutions and survivors of abuse and trafficking. In year 2 of our Leher programme we were able to see organisations go through Phase 1 which included intensive training on understanding the right to protection for children, and risks to women and children in their program communities while also becoming equipped with information and skills to identify, respond to and prevent abuse, violence and exploitation in their communities. They then chose elements of Phase 2 based on their own plans and abilities. We are proud to say that Laksh Foundation has entered Phase 3 of the programme and we will be working with them on establishing a safe space in Mangar village, collaboratively.

Some of the highlights of Leher in 2021-2022 were –

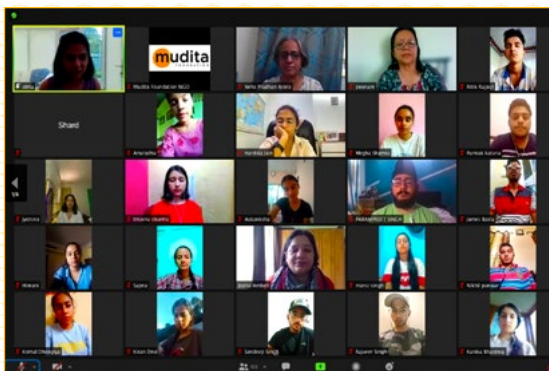
- A first of its kind engagement was with the shelter home staff of Kishanganj, Bihar, in partnership with Vihaan. 12 staff members from the girls and boys home with the support of the ADCPU attended 10 sessions exploring child rights, specific laws, systems and rescue mechanisms involved in ensuring the safety of children in need of care and protection.



- Our first interaction with staff from a field partner in Karnataka who work with vulnerable communities. The interaction focused on building their capacities to use participatory tools with adolescent girls to include their perspective in a baseline assessment being conducted. Safety mapping, Ranking and other tools developed by the Mudita team were conducted and shared with them.

- Leher programme with Foster and Forge mentors allowed us to reach a huge network of teachers and parents through a series of WhatsApp awareness messages that we created to circulate information about child abuse and child safety.
- First Leher programme with a University was conducted for 200 first-year students of Shoolini University, in Solan Valley of Himachal Pradesh, as part of their social project. Over 6 sessions, students were engaged in a process of awareness, reflection and action in the context of the risks around them, in the context of abuse, violence and exploitation. This was the first time that Mudita Foundation collaborated with a university and interacted with such a large and diverse youth group, at an institutional level. These interactions brought to light the vulnerability of youth, the risks faced by them in public and private spaces and the absence of spaces that allow them to share, ask questions or seek help.

enriching conversation with 10 dynamic individuals representing 7 organisations from 5 different locations of the country. Some of our participants joined online as well. Together we reflected on what is being done, ideated about what can and should be done and reiterated the call for action- integrating the safety approach in their existing work objectives.

The first Leher Confluence:

On December 3rd, Mudita Foundation organised its first Leher Confluence, inviting all the partner organisations together to share their experiences, efforts and challenges in advancing a safer environment in their respective fields after the training with us. What ensued was a very



IMPACT OF LEHER :

By November 2021, we had completed the Leher program with 8 organizations, training 125 participants through 70 sessions. The true impact of this program is not to be counted in numbers but in action. 6 months after completing the phase 1 of Leher, a review meeting was held for 3 of our partner organizations separately. The Leher review meet aims to assess the impact of the training sessions/program on the participants, understand their perception on children's safety post training and get their inputs on what more they might want to know from us about the issue and how they would like to plan and execute the prevention programs they had designed during the training.

It was encouraging that teachers in Ritinjali- one of our partner organisations-started conducting regular sessions with children on identifying safe and unsafe situations. They also chose 'Safety of Children' as the theme of their annual festival and presented songs and drama on issues of child abuse.

Laksh Foundation expressed the need to be able to respond to cases of child abuse with a holistic approach and began working on drafting their organisational child protection policy.

Kutumb Foundation finalized their child protection policy and an orientation session for the team was conducted by Mudita Foundation. They also integrated the issue of safety into their theatre programme by creating short video case stories to use with children to initiate conversations on safety.

This is exactly the kind of impact we aspired to achieve when 'Leher' was conceived as an idea, for we at Mudita Foundation firmly believe that no matter what aspect of development we are working on, safety from abuse, violence and exploitation must be integrated into the programme to ensure real impact.





Sameeksha

The issues of child sexual abuse and human trafficking are complex and multi-faceted. They continue to evolve in form and operation. Thus, in order to continually probe and explore these issues, we at Mudita Foundation consciously make research a part of our approach. Sameeksha - an evidence-based research unit - works designing and executing participatory tools and research studies to complement and support the work we do.

Key objectives of Sameeksha are:

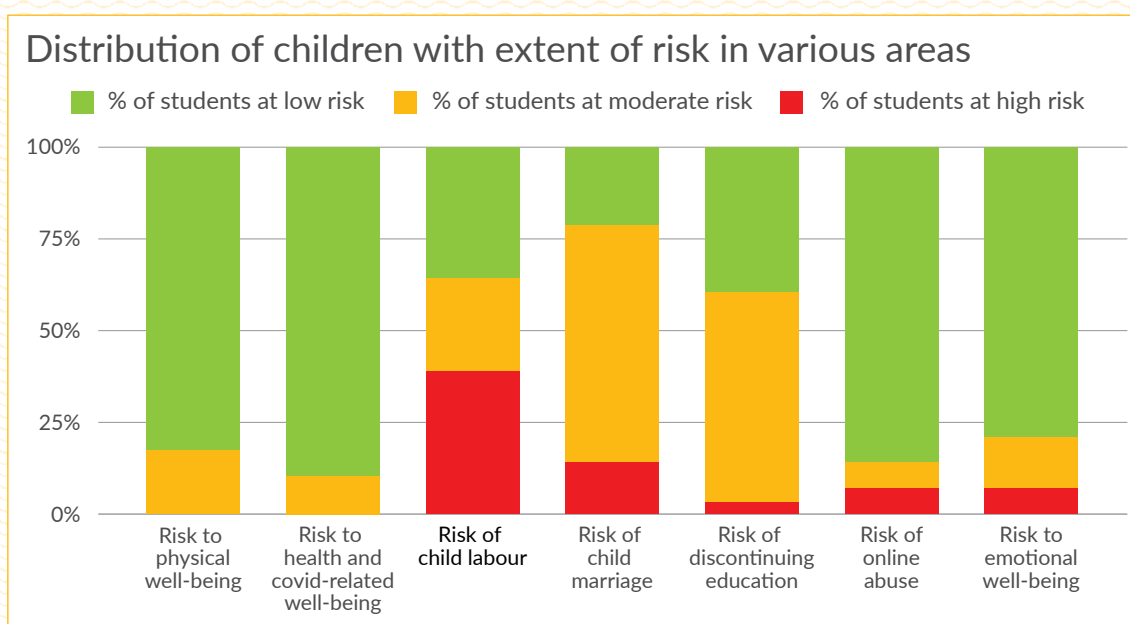
- To develop a deeper understanding of key issues related to abuse, violence and exploitation, in the context of India
- To develop and use participatory tools for collection of field data in the context of abuse, violence and exploitation
- To transform key insights into accessible formats that can be shared with a larger audience
- To create a curated repository of resources on relevant themes to assist practitioners

In the year 2021-2022, we continued work on documenting children's voices during the Covid-19 pandemic, in order to understand their needs, priorities and their conceptualization of their own well-being. This study also attempted to probe into emotional, physical, cognitive, and social risks that may have been aggravated by the pandemic, which can make children more vulnerable to abuse and exploitation. This study was carried out in collaboration with four partner organizations spread over Noida, Delhi, Kolkata, and Faridabad. Field facilitators of these organizations surveyed over 220 children to document risks perceived by children in a variety of forms - such as child labour, child marriage, online abuse, emotional abuse, among others. Data was analyzed by Mudita Foundation and a summary report was submitted to each partner organization to ensure that the partner organizations were able to take the requisite action to prevent or respond to these risks immediately.

–A Dialogue

“The act of collaboration must start with dialogue. You cannot build relationships without having an understanding of your potential partners, and you cannot achieve that understanding without a special form of communication that goes beyond ordinary conversation.” –Daniel Yankelovich

One of our initiatives to build collective consensus, effort and impact is Baatchheet Live - a platform for practitioners and organisations to come together to create a space for learning, share knowledge and experience and build collective responsibility for the safety and wellbeing of women and children in communities.

In the year 2021-2022, we leveraged this platform to explore resilience as a concept and practice in the face of abuse, violence and exploitation that continues to prevail in our society despite several efforts. We invited experts from diverse fields to share their experiences and tools that can creatively help build resilience in those who are survivors of abuse or are vulnerable to it.

This year we hosted 3 editions of Baatchheet Live, tapping collaborative synergies with 8 experts and 4 organisations- Swayam, SMART, EmancipAction India Foundation and ArtReach. The themes explored were as follows :

- Building resilience through inner balance and self awareness tools.
- Building Resilience through art-based tools
- Understanding Domestic Violence and its Impact on Children's Safety

Other Activities :

- 1. Daan Utsav 2021:** A unique festival celebrated in India, Daan Utsav celebrates and endorses the joy of giving by encouraging individuals, communities, organizations, institutions and almost every human by doing an act of kindness. It is a movement observed from 2nd to 8th October annually, that brings people from all walks of life together to give back to the society.

Mudita Foundation too celebrated this wonderful week of kindness through a host of activities. On 2nd October, we organized a free online story telling

session on personal safety for children and parents. We also engaged people in a campaign #GiveTogetherStayTogether, encouraging friends and family to come forward and support our cause. On 8th October, we also launched our very first audio visual resource ' RAISE your HAND with Mudita Foundation to fight child abuse', to take the issue of child abuse to each and every individual of this country, raising awareness and consciousness that we owe our children a safer world because each one of us has a role to play. To take the movement to a wider audience, we reached out through an Instagram live session with Ms Puja Amin from Circles Of Safety. Some short The week culminated with #Dance4safety with a Kathak and Odissi dance exponent, Ms Kristina Luna. This was a two day classical dance workshop hosted by Courses for Charity to support Mudita Foundation and raise awareness about the issue of child safety from sexual abuse.

2. Child Safety Week 2021: The week from 14-20th November this year was indeed one of the most exciting phases for our team. We were finally back on field for in person sessions and the energy reciprocated to us was extremely encouraging. The theme this year for the Child Safety Week, across the nation was to bring everybody's attention that it is not too late. That #NowIsTheTime to take action; to create awareness, prevent, tackle and fight child sexual abuse. In keeping with the same, Mudita Foundation conducted 24 sessions on personal safety, reaching out to 850+ children, collaboratively with our partner organisations Laksh Foundation & Kutumb Foundation. During the week, we trained these organisations on initiating conversations about personal safety using creative tools like storytelling, games, movement and art.

A series of short awareness videos on case studies pertaining to child abuse were developed by our Leher partner Kutumb Foundation's Drama in Education team. These videos were shared on social media platforms engaging the audience in reflective questions.



3. Women's Day Celebrations: Mudita Foundation was at Navjyoti India Foundation this year to celebrate women's day. This was also the marking of our new collaboration with them starting April 2022.

We conducted an awareness interaction for more than 60 women in Sohna Block. There was dance, laughter, games and activities that eventually led all of us to acknowledge the urgent need for tackling safety issues. The day culminated on an inspiring and hopeful note as everybody present at the event shared willingness to work towards creating a safer community together.


